- We only hold data (e.g. personal and company information) to support the business service that we provide to our clients.
- All information collected about you via our website is the sole property of York
 Pullman Bus Co Ltd and it will not be shared, sold, or released to any other entity
 without your consent, except where it is required by law and/or legal processes.
- Your details will be added to the York Pullman Bus Co Ltd database in order to
 process your quotation, booking, bus pass request, fulfil our contractual obligations,
 and keep you up to date with relevant changes to our products and services.
- We will respond immediately to questions about the accuracy of information we hold and process for our clients.
- We will monitor privacy issues on an on-going basis to ensure that any changes in legislation or industry standards regarding privacy issues are reflected in our Privacy Policy and understood by our employees.
- We will maintain strict data security systems that ensure specific individual information will not be made available to any unauthorised person.

INFORMATION WE COLLECT ABOUT YOU

Information you give to us.

This refers to information collected as part of your communications with York Pullman Bus Co Ltd such as, by phone, email, social media channels/website, face to face meetings or submission of online or hard copy forms.

- 1. Requests for quotations/bookings for private coach hires, excursions, school trips and weddings. This information can include name, name of school/company/organisation, email, postal address, telephone (landline and mobile), bank account and credit card details.
- 2. Contractual transport services such as 'home to school transport'. This includes information such as your school name, school address, school business email address, business phone number and contact details of key members of staff.

3. Provision of school bus passes. This information includes school name, school address, school business email address, business phone number and contact details of key members of staff and pupil photo ID, name, address, DOB, Parent/Carer's Details, parent/carer bank and payment details.

Information we collect automatically

With regards to each of your visits to our website, we will collect the following information:

 Information that does not identify you: this includes analytical information about your visits to the website; your IP address, geographical location, browser type and version, operating system, source of referral, how long your visit is and which pages you look at.

WHO WE SHARE YOUR PERSONAL DATA WITH

Your personal data is never sold or made available to a third party.

There may also be circumstances where we are under a duty to disclose your personal information or share your personal information in order to comply with any legal or regulatory requirement, obligation or request. This includes the police for the prevention or investigation of a crime or our Insurers, legal advisors or other third parties who need access to it in the context of managing, investigating or defending claims or complaints.

COOKIES

What is a cookie?

A "cookie" is a small file containing a string of characters that is sent to your computer when you visit a website. When you visit the website again, the cookie allows that site to recognise your browser and recall your user preferences, giving you a better experience of the site. Cookies may store user preferences and other information for this purpose. You can reset your browser to refuse all cookies or to indicate when a cookie is being sent. _utmz: records whether the visitor came from a search engine (and if so, the search keyword used), a link, or from no previous page (e.g. a bookmark).

These cookies enable the function of Google Analytics software. This software helps us take and analyse visitor information such as browser usage, new visitor numbers, response to marketing activity and shopping times. That information helps us to improve the website.

The data stored by these cookies do not identify people and do not collect any personal data.

Backups of electronically stored data are taken regularly, with strong encryption used to protect all files.

York Pullman Bus Co Ltd maintains its statutory rights to hold data for as long as is required for legitimate purposes and legal regulations.

HOW CAN I SEE WHAT INFORMATION YOU HAVE ON ME?

You have the right to get a copy of the information that is held, collected, stored and used about you, at any time. This is called a Subject Access Request. In most cases you will not

be charged for making a request. However, York Pullman Bus Co Ltd can refuse or charge for requests that are manifestly unfounded or excessive.

By law you have the following rights:-

- 1. The right to be informed you can make a request regarding the data York Pullman Bus Co Ltd collect, store and use about you.
- 2. The right of access you have the right to know exactly what information is held about you and how it is processed.
- 3. The right of rectification you are entitled to have personal data rectified if it is inaccurate or incomplete or to notify us of any changes to your circumstances i.e.: address, contact details, email address etc. to ensure accurate records are maintained.
- 4. The right to erasure also known as 'the right to be forgotten', this refers to an individual's right to having their personal data removed subject to legitimate or legal requirements.
- 5. The right to restrict processing your right to block or suppress processing of your personal data.
- 6. The right to data portability allows you to retain and reuse your personal data for your own purpose.
- 7. The right to object in certain circumstances, you are entitled to object to your personal data being used
- 8. Rights of automated decision making and profiling safeguards to protect individuals against the risk that a potentially damaging decision is made without human intervention.
